### Call for Papers First Announcement

It is now recognised that the regulatory agencies that have responsibility for the environment, must also now consider the impact of the environment on human health. Conversely, the medical community must extend their boundaries beyond the traditional boundaries of public health. This meeting aims to bring together Environmental Chemists, Ecotoxicologists, Biologists, Clinicians, Environmental Health and Public Health Professionals together to debate the current state of the science, science policy, and communication systems amongst these groups. Oral presentations and posters are invited on the following themes:-

- Measuring and monitoring contaminants in the environment.
- Soil, agriculture, and safety of the human food chain.
- Drinking water contamination.
- Air pollution and respiratory health.
- Metals, organic contaminants, or radioactive substances and human health.
- Ecotoxicology, biomarkers, and surrogate indicators of hazards to human health.
- Establishing common tools/techniques, communication and policy.
- Disaster management and long term/latent effects of pollution on health.
- Climate change and pollution effects on human health.
- Emerging contaminants or human health issues.
